#### The Chair

The Chair shall be the principal executive officer of TGCRVOAD and, subject to the control of the Executive Committee, shall generally supervise and control all business and affairs of the organization.

The Chair shall preside at all meetings of the General Membership and Executive Committee.

The Chair shall generally perform all duties incident to the office of the Chair and such other duties as may be prescribed by the Executive Committee from time to time.

The Chair has an ex-officio seat on TGCRVOAD committees, convenes meetings, and provides leadership.

The Chair nominates committee chairs to be voted on by the officers.

The Chair may engage in external contracts with the voting membership's consent.

The Chair designates official TGCRVOAD representatives for any activated Emergency Operation Centers (EOCs) in the region.

#### The Vice Chair

The Vice-Chair shall preside at meetings of TGCRVOAD and the Executive Committee in the absence of the Chair.
