Executive Committee Actions

The Executive Committee met in December and took the following actions:

- We resolved a question regarding interpreting the Bylaws and the eligibility to hold office. We agreed that our Bylaws allow any duly designated Primary or Alternate representative of a Member is eligible to hold office as a representative of the Member even if that person is employed by a government entity.
- LTRCs, Chambers of Commerce, and other associations of nonprofits engaged in short-, intermediate, or long-term recovery will be considered for membership as Members of the TGCRVOAD.
- 2024 dues for Members will be \$50, payable by March 31st. We waived 2003 dues for organizations that join after September 30th.
- That Helping Hands to the Community, Fifth Ward CRC, and SBP be listed as an Inactive Members
- Any Inactive Member may reinstate their Membership and be considered a Member in Good Standing if
 - They meet all the terms to be considered a Member in Good Standing as outlined in the Consensus of Engagement, and
 - 2. They pay any prior year past due dues, up to a maximum of one year.
